1. Definitions and Interpretation

1.1 In these Terms of Use, unless the context otherwise requires, the following expressions have the following meanings:

“Account”	means an account required to access certain features on Our Site, as set out in Part 7;
“Content”	means any and all text, images, audio, video, scripts, code, software, databases, and any other form of information capable of being stored on a computer that appears on, or forms part of, Our Site;
“User”	means a user of Our Site;
“User Content”	means Goods for sale, reviews, comments, shared by Users on Our Site; and
“We/Us/Our”	means Naturekissd Hair & Skin.

2. Information About Us

 - l) is intended or otherwise likely to infringe (or threaten to infringe) another person's right to privacy or otherwise uses their personal information in a way that you do not have a right to;
 - m) misleadingly impersonates any person or otherwise misrepresents your identity or affiliation in a way that is calculated to deceive (obvious parodies are not included in this definition provided that they do not breach any of the other content standards in this Part 3);
 - n) implies any form of affiliation with Us or any other party where there is none;
 - o) infringes, or assists in the infringement of, the intellectual property rights (including, but not limited to, copyright, designs, patents, trade marks, and database rights) belonging to Us or any other party;
 - p) is in breach of any legal duty owed to another party including, but not limited to, contractual duties and duties of confidence.
- 3.3 We may monitor any and all communications made using Our Contact Tools.
- 3.4 Any personal information sent to Us, whether via Our Contact Tools or otherwise (including, but not limited to, your name and contact details) will be collected, used, and held in accordance with your rights and Our obligations under data protection law, as set out in Our Privacy Policy, available from <https://naturekisssd.com/privacy-policy/>.

4. **Access to Our Site**

- 4.1 Access to Our Site is free of charge.

 - f) Any other actions which We deem reasonably appropriate (and lawful).

17. **Communications from Us**

18. **What Happens if We Transfer this Agreement to Another Party**

- 19.3 If you are a consumer, any dispute, controversy, proceedings, or claim between you and Us relating to these Terms of Use or to the relationship between you and Us (whether contractual or otherwise) shall be subject to the jurisdiction of the courts of England, Wales, Scotland, or Northern Ireland, as determined by your residency.
- 19.4 If you are a business user, any dispute, controversy, proceedings, or claim

between you and Us relating to these Terms of Use or to the relationship between you and Us (whether contractual or otherwise) shall be subject to the exclusive jurisdiction of the courts of England and Wales.
